

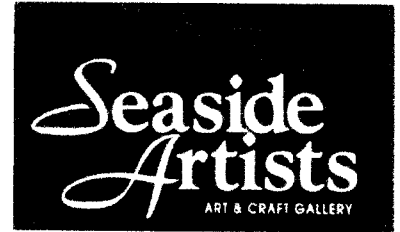

Contract of Agreement between the Gallery and Contributing Artist

I agree to the following terms and conditions for the display of those of my art works accepted and offered for sale by Seaside Artists Gallery: (please tick option)

Either

The gallery shall offer each piece for sale at the price nominated by me, with a **commission of 25%** to the gallery included in my price. I accept fees of: **\$35 per year MEMBERSHIP FEE + 6 hours per month Gallery VOLUNTEER TIME**

Or

The gallery shall offer each piece for sale at the price nominated by me, with a **commission of 35%** to the gallery included in my price. I accept fees of **\$50 per year MEMBERSHIP FEE and nil volunteer hours.**

- I am responsible for the transport of my work to the gallery and also for transport of any items returned to me. Any item of my work may be taken to a potential client's home, by a gallery worker, for an in house appraisal.
- I am free to remove my work (eg for a competition, exhibition etc) upon notice given to the gallery. I understand that it is unethical for me to remove my work for private sale, in order to avoid commission.
- The gallery will notify me immediately if any of my work is lost, stolen or damaged. I understand that the gallery has full cover for any incident, including fire, storm and malicious damage, and full compensation will be recovered if any of my work is lost, stolen or damaged.
- I retain all rights of ownership of my work until sold (when title passes directly to the purchaser).
- The Gallery shall send out monthly statements of sale with payments for any works sold.
- Copyright remains with me, however, I authorise the Gallery to reproduce any of my works, when they are to be used strictly for advertising and promotional uses only.
- I undertake to present work of the highest standard to the gallery. I accept that work not professionally presented (eg damaged or old frames, dirty glass or mats, mildewed backing; dirty sculpture or pottery – no abrasive bases etc) could be refused. Each hanging piece of artwork is required to have two D hooks for appropriate hanging.
- I will provide the gallery with a current CV.
- Individual pieces of my work will remain in the gallery for a period of three months, or until sold. I undertake to maintain monthly contact with the gallery and to up date my works on the required basis.
- I will provide the gallery, when necessary, with the means of displaying my work.
- I give permission for my works to be displayed on the Seaside Artists Website – www.sea-sideartists.com
